# **FRRPD SPORTS TOURNAMENT/LEAGUE RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY**

ALL MANAGERS ARE HELD RESPONSIBLE FOR THEIR PLAYERS' ACTIONS OF PLAY, KNOWLEDGE OF LEAGUE RULES, PLAYER CONTRACTS, AND KNOWLEDGE OF THE "PLAYER CODE OF CONDUCT".

## **Behavior and Sportsmanship Guidelines**

It is every player's responsibility to know the rules and abide by them. It is also every player's responsibility to respect and cooperate with the officials and facility attendant. It is the responsibility of the team manager to insure proper behavior on the part of his/her team's fans. All infractions will be governed by the Players Code of Conduct.

## **Player Code of Conduct**

The objective of FRRPD Sports Leagues is to provide the opportunity for participants to benefit from a quality leisure time activity which encourages fitness, healthy competition, fun and fellowship in the form of organized sports. Friendly competition and good spirited rivalry are expected. However, Officials and Facility Attendants are FRRPD employees and will not tolerate verbal or physical abuse or threats from or amongst players, coaches or spectators. Inappropriate conduct can result in penalties ranging from game ejection to lifetime suspension. The Official or Facility Attendant may forfeit games if either team's participants or supporters act in such a way as to interfere with proper conduct of the game.

**Conversations with officials/umpires will be kept to a minimum.** Team managers, and only team managers, may address the officials. Managers may only address matters of rule interpretation or essential game information and must do so in a courteous manner.

## **Blood Rule**

A player with a bloody injury or blood on his/her uniform must leave the game. The player may not return to the game until the wound is no longer bleeding, the wound is covered or the uniform is changed.

## **No Drugs/Alcohol/Tobacco**

No glass bottles allowed, due to them being a safety hazard. No smoking, chewing or drinking on or near the fields.

## **Equipment**

Men's division will play with a 12" softball. Coed divisions will play with a 11" softball.

No one at any time may use illegal equipment including altered or ASA banned illegal bats, metal cleats or exposed dangerous jewelry.

If found in violation of this rule immediate ejection from the game and a minimum of a one game suspension or maximum of a lifetime suspension will be enforced. Penalty is up to discretion of Recreation Supervisor.

## **Agreement Waiver and Release**

*I have carefully read the description of the program(s) for which I/we are registering and in consideration for being permitted by the Feather River Recreation and Park District to participate in the above activity. I hereby waive, release and discharge any and all claims for damages for personal injury, death or property damage which I may have, or which may hereafter accrue to me, as a result of participation in said activity. This release is intended to discharge in advance the Feather River Recreation and Park District (its officers, employees, and agents) from any and all liability arising out of or connected in any way with my participation in said activity, even though that liability may arise out of negligence of carelessness on the part of the person or entities mentioned above. It is understood that this activity involves an element of risk and danger of accidents and knowing those risks. It is further agreed that this waiver, release and assumption risk is to be binding on my heirs and assigns. I agree to indemnify and to hold the above persons or entities free and harmless from any loss, liability, damage, cost or expense which they may incur as the result of my death or any injury or property damage that I may sustain while participating in said activity. Parental Consent: (to be completed and signed by parent/guardian if applicant is under 18 years of age). I hereby consent that my son/daughter may participate in the above activity. I hereby execute the above agreement, Waiver, and Release on his/her behalf. I state that said minor is physically able to participate in said activity. I hereby agree to indemnify and hold the persons and entities mentioned harmless from any loss, liability, damage, cost or expense which they may incur as a result of death or injury or property damage that said minor may sustain while participating in said activity.*

**\*I have carefully read this Agreement, Waiver and Release and fully understand its contents. I am aware that this is a release of liability and a contract between me and the Feather River Recreation and Park District and I sign it of my own free will.**
