- 1. TIMES.** Set up will begin no earlier than 7:00am. Event hours are 10:00am – 4:00pm. Breakdown before 4:00pm is prohibited and may result in vendor suspension from future events.
- 2. RAIN OR SHINE EVENT.** Please prepare for all weather conditions. Vendor fees are non-refundable, with the exception of FRRPD event cancellation.
- 3. VENDOR SPACE.** Booth spaces are 12'x15' each. Vendors must purchase multiple spaces if additional space is required. Vendors are responsible for furnishing their booth including a canopy, tables, and chairs.
- 4. PARKING.** After unloading your vehicle, please move it to the designated parking area to maximize parking for customers and event participants.
- 5. APPROVAL PROCESS.** All vendor applications are subject to an approval process. Vendors will be contacted if/when their application is approved. Commercial items must be nature related or hand made. If false information is provided on any application regarding product information or services offered, that vendor will be asked to leave the event.
- 6. COMPETING VENDORS.** FRRPD takes pride in the unique qualities of this event and discourages competing vendors to maximize profits.
- 7. FIRST REGISTERED, FIRST SERVED.** Your application may be denied if there are already vendors selling like items. We recommend that you submit your application as soon as possible to avoid any conflicts.

- 8. **SPECIAL REQUESTS.** Special requests are at the discretion of the event committee and must be made on this form to be considered. Please include your request below.
- 9. **COMMERCIAL VENDORS:** Must obtain a valid Seller’s Permit and have it available during the event.
- 10. **FOOD VENDORS:** Food vendor booths or trucks must include a copy of their Business License and Butte County Health Permit with the application.
- 11. **VENDOR USE AGREEMENT. *Please read carefully before signing.*** By signing my name hereto, I agree to be solely responsible for any and all liability, claims, loss, damages, costs and expenses, including attorneys’ fees, arising out of or resulting from any injury to persons or damage to property which arise out of my use of the District’s facilities.
