- 1. Generate plans/drawings necessary for repairs, renovations and permitting.
- 2. Performance and payment bonding.
- 3. Demo, prep, and bond coats for new plaster.
- 4. Repair skimmer seals at face and tile line.
- 5. New tile for step tiles.
 - a. Remove lane tiles and wall markers.
- 6. Replace two center wall anchors
- 7. Replace Break line Tile
- 8. New pool equipment, (Main pump, Danfoss VLT VFD, Chemtrol chemical controller, Pulsar chlorine feeder, acid tank and Prominent Concept Plus acid pump, auto fill water system, and flow meter).
- 9. Necessary project plumbing. Clean up pool plumbing with SCH 80 PVC, required valves, and strut support systems.
- 10. Electrical, clean up existing electrical to meet current codes and update for new equipment.
- 11. Plaster pool
- 12. Final, start up, and balance
- Payment Terms: Net 30 upon completion of project.
